**\* Doctoral Committee:**

For each research scholar, a three member doctoral committee consisting of guide and two experts from within Tamilnadu (one member is HOD) may be formed from the panel of experts submitted by the research supervisor through proper channel and the Vice-Chancellor will nominate the expert from the panel.
