In the interview held on 06/07/2014, **Mr.S.Arumugaraj** has been selected for the post of **Assistant Professor** in the department of **Commerce**. This appointment is purely temporary. He has been offered a basic pay of Rs.8550/-+DA + HRA with a Special Pay of Rs.250/- (for NET) per month.

2. He is requested to join duty immediately. He is informed that he should continue to serve our institution at least upto the end of the current academic year. He would not be relieved in the middle of the academic year.

3. While working at Kongu Arts and Science College, if he wants to apply for outside job, he has to send the application with the permission of the Management. If he wants to leave our institution as per the conditions mentioned in the appointment order, he should give two months notice or in lieu thereof, he should remit two months salary before leaving our institution. The Management also reserves its right to terminate his services without assigning any reasons at any time.

4. The appointment is also made subject to the other terms and conditions agreed upon at the time of interview.

5. He should submit all the original certificates of his Educational Qualifications, Conduct, Age, Experience etc. at the time of his reporting for duty.

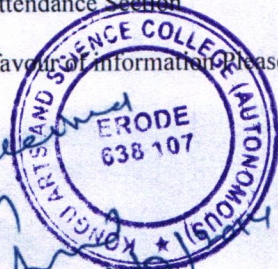
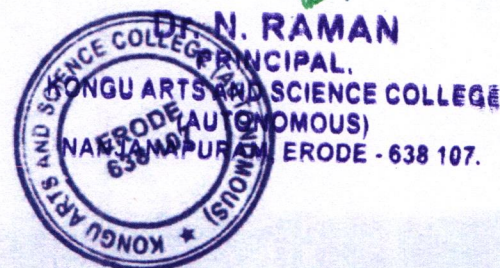

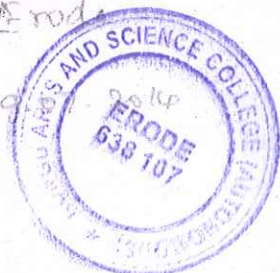

College.

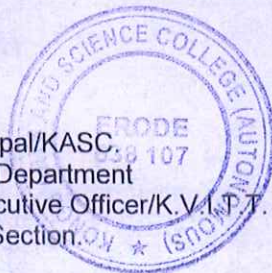
