5. He should submit all the original certificates of his Educational Qualifications, Conduct, Age, Experience etc. at the time of his reporting for duty.

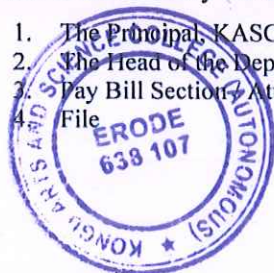
