



## Memorandum of Understanding

Between

Prince of Songkla University  
Surat Thani Campus, Thailand

And

Kongu Arts and Science College (Autonomous)  
Erode, India




This Memorandum of Understanding (MOU) is made and entered into by and between Prince of Songkla University at Surat Thani Campus 84000, Thailand, hereinafter referred to as PSU; and Kongu Arts and Science College, located at Nanjanapuram, Erode, Tamil Nadu, India herein referred to as KASC;

Based upon the principles of equality and mutual benefits and in order to promote deeper understanding between Thailand and India, PSU and KASC agree as follows:

1. The two parties agree on educational and academic collaboration in the following activities
  - a. Student and Staff exchange
  - b. Joint research activities and publications
  - c. Other activities which benefit to academic and educational programs of both parties.
2. The final approval of any project will be dependent upon the availability of guaranteed support funds.
3. The host university will provide free accommodation for the participants in the students and staff exchange program.
4. This MOU will be effective for five years from the date of the signing and may be revised with the consent of both parties.
5. If either party wishes to terminate this agreement, they shall notice in writing to the other party no less than one hundred twenty (120) days prior to its expiration.

Each party will appoint a person in charge (representative) in order that joint activities can be carried out smoothly. The nominated representative of Kongu Arts and Science College (KASC), is the Principal and the nominated representative of Prince of Songkla University (PSU), Surat Thani Campus is Assistant President of International Affairs, Cooperative Education and Special Affairs.

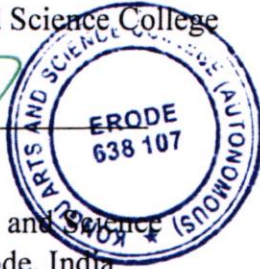
