Sub: Ragging Prevention in our College – Action taken report – reg.

With reference to the above, a report on the action taken by our college for prevention of ragging:

1. We have kept large, visible boards (painted in black colour bearing letters in white) containing warning and consequences of ragging in front of the college campus and in both the hostel premises(Photos enclosed).
2. A ragging complaint box has also been installed in front of the Principal's chamber along with phone number of Principal, Registrar of Bharathiar University and near by Police Station(Photo enclosed).
3. Apart from ragging curb committee (copy enclosed), an Anti-ragging committee comprising of Faculty Members(List enclosed) for the academic year 2018-19 has also been formed to prevent ragging inside the college premises and near the college bus stop (lists enclosed).
4. Both the Ragging Curb Committee and the Anti-ragging Committee have equal representation of female faculty members to address the needs of the girl students.
5. As per the letter dated 25.05.2018 from UGC, Anti-Ragging Squad comprising of senior students including NSS Volunteers and NCC Cadets for the academic year 2018-19 has also been formed.
6. A circular to all the students for ragging prevention has been circulated (copy enclosed).
7. Undertaking by the student and parent, as per the Gazette of India, New Delhi has been obtained. (copy enclosed).



10. Separate floor for the fresh students in both the hostels have been provided.
11. Contact Number of the CURB Committee Chairman has been printed in the Identity Card of the First year Students (Photos enclosed)
12. Random checking in College buses was done and a meeting with all the bus drivers was conducted in this regard.
13. Surprise inspection of hostels, canteen, toilets and bus stop was carried out.
14. Videos on Ragging (downloaded from the UGC website) were screened to counsel the II and III year UG students on the ill effects of ragging.
15. Periodical report on Anti-Ragging measures as per the instructions in the above cited letter is also enclosed.
