B.Com Corporate Secretaryship with CA

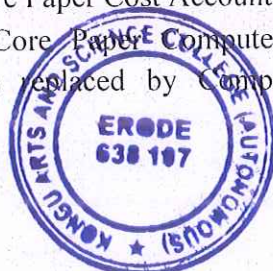
The following modifications are done in the Syllabi of III and IV Semesters for the B.Com Corporate Secretaryship with CA students admitted during the academic year 2017 – 2018 and onwards based on the feedback obtained from Stakeholders and recommendations of the BOS Panel Members.

- In Semester III, Skill Based Course Law of Insurance (15UAGST306) is replaced by Marketing Management(17UAGST306)
- Non Major Elective Courses (NME I: Company Law NME II: Practical Banking) are being introduced newly in III and IV semesters for UG Students.
- In Semester IV, Skill Based Course Banking Theory Law & Practice (15UAGST406) is replaced by Human Resource Management(17UAGST406)
- Modification by addition and removal of topics are carried out in the in the syllabi of I and II, V and VI Semesters (Refer Annexure b)

B.Com Professional Accounting

The following modifications are done in the Syllabi of III and IV Semesters for the B.Com Professional Accounting students admitted during the academic year 2017 – 2018 and onwards based on the feedback obtained from Stakeholders and recommendations of the BOS Panel Members.

- In Semester III, Core paper Advanced Accounting(15UAGCT303) is removed.
- Core Paper Corporate Accounting (15UAGCT501) in Semester V is split into Corporate Accounting I (17UAGCT301) and Corporate Accounting II (17UAGCT401) in Semester III and Semester IV.
- In Semester III, Core paper Business Environment and Ethics (15UAGCT304) is replaced by Business Law Ethics And Communication (17UAGCT304).
- In Semester III, Skill Based Course I Organisational Behaviour (15UAGST306) is replaced by Human Resource Management (17UAGST306).
- Non Major Elective Courses (NME I: Fundamentals of Accounting ,NME II: Practical Auditing) are being introduced newly in III and IV semesters for UG Students.
- In Semester IV, Core Paper Cost Accounting(15UAGCT401) is shifted to Semester V.
- In Semester IV, Core Paper Computer applications Practical II (Tally & Oracle) (15UAGCP404) is replaced by Computer applications Practical II (Tally & Oracle) (17UAGCP404)

Modification by addition and removal of topics are carried out in the in the syllabi of I and II, V and VI Semesters (Refer Annexure-b)



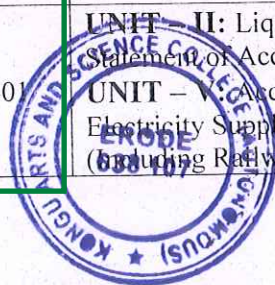
