

Details of Modifications in the Courses offered under the programme

B.Com Corporate Secretaryship with CA

The following modifications are done in the Syllabi of I and II Semesters for the B.Com Corporate Secretaryship with CA students admitted during the academic year 2020 – 2021 and onwards based on the feedback obtained from Stakeholders and recommendations of the BOS Panel Members.

- The Allied Paper Principles of Management is removed from Semester I due to incorporation of Professional English I.
- The Allied Paper Business Law is shifted from Semester III to Semester II and Professional English II s also incorporated in this Semester.
- Modification by addition and removal of topics are carried out in the in the syllabi of I and II Semesters (Refer Annexure-b)

B.Com Professional Accounting

The following modifications are done in the Syllabi of I and II Semesters for the B.Com Professional Accounting students admitted during the academic year 2020 – 2021 and onwards based on the feedback obtained from Stakeholders and recommendations of the BOS Panel Members.

- The Core Paper Mercantile Law is modified and shifted from Semester I to Semester III and introduced as Business Law. A new Course Professional English I and Office Automation is also incorporated in Semester I.
- In Semester II Computer Applications Practical –I (MS Office) is renamed as Computer Practical –I (Office Package).
- Non Major Elective Courses (NME II: Right to Information) is being introduced newly in IV semesters for Psychology Students due to increase in strength in B.Com(PA).
