1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Kongu Arts and Science College is a premier Co-educational Self-financing Institution founded by the Kongu Vellalar Institute of Technology Trust in 1994 with a dream to uplift the youth of this region to greater heights with ethical and moral values. It is affiliated to the Bharathiar University, Coimbatore, Tamilnadu and stands unique in imparting quality education by setting its stand as the most preferable College in Erode. Our College was started with 89 students and 7 faculty members, and at present the strength of our College is 3823 with 192 faculty members and offers 23–UG, 11-PG and 10 Research Programmes. It is recognized by UGC 2(f), 12(B) and AICTE and it has obtained Autonomous Extension Status in 2022. Our College pervades through 27.24 acres of panaromic milieu and is located 10 KMS away from Erode Bus Stand and Erode Railway Station.

Kongu Arts and Science College has entered in the 29th year Academic Excellence and has achieved renowned ranking in the competitive line of other Higher Educational Institutions because of the dynamic Management coupled with the dedicated Principal and highly motivated Faculty Members. Outcome Based Curriculum was introduced in our College in 2017 and Student-centric approach has been followed in the Teaching Learning process.

Our College was recognized under DBT Star College Scheme in 2019 with an initial grant of Rs. 1.04 Crore and also got two years extension with a grant of Rs.36 lakhs. Our Institution was ranked FIRST for upholding SWATCHA in 2017 by MHRD. **India Today** magazine has ranked our College as one among the top 100 Colleges in India consecutively from 2017. The ICT Academy has honoured our College under the category "Employability Enhancement" in 2017 and 2018. 1.3 CRITERIA WISE SUMMARY

Curricular Aspects

Our College always ascribes significance in framing the Curriculum to focus on the Employability, Entrepreneurship skills of the students in tune with National Education Policy. Courses are designed in tune with the regional, local, national and global needs. Revision in the curriculum is made based on the requirements of the industry and the feedback received from the stakeholders. The framework of the curriculum gets absorbed in the Program Outcome (PO), Program Specific Outcome (PSO) and Course Outcome (CO) of the programs offered in the college. Need based courses are included in the program with advanced topics. Our College practices Choice Based Credit System and Outcome Based Teaching learning framework. Since every course is designed in accordance with the societal needs, the required changes are done based on the feedback received from the faculty members, students, alumni and employers. The feedback received are discussed with the Department Advisory Committee and based on the recommendations of the Board of Studies, revisions are carried out.

Online courses like MOOC, NPTEL are also included in all the programs to enable the students keep pace with the changing trends in the educational scenario. Need based Value Added Courses are offered by all the Departments to assist the students choose interdisciplinary courses and get integrated in enhancing their skills. Training and Placement Cell of our College offers Value Based Courses jointly with TCS and INFOSYS to pave an easy way for student placements. Computer Science with Data Analytics was introduced during the asesement period as an industry oriented Course to enhance proactive learning and to promote innovative thinking.

Almost all the programs offer courses highlighting Gender, Environment, Human Values and Professional Ethics. Every discipline gives special guidance to Advanced Learners by encouraging them to take up additional Online Courses like SWAYAM and NPTEL courses and in general all the students are offered Elective Courses as Choice Based Courses. Many student- centric learning activities like Field Visits, Industrial Visits, Internship Training are offered to equip them to confront real life situations. Project work is allotted to both UG and PG students to provide them an exposure to individual practical and innovative learning ambience.

Teaching-learning and Evaluation

The institution uses a variety of teaching and learning techniques to enhance the educational process as a whole. Students are admitted in accordance with the requirements outlined by the Bharathiar University and Government of Tamilnadu. The Institution includes committed Teachers and students from rural background. The institution is proactive in improving student mentorship across all academic endeavours.

Students' learning and performance are being evaluated using approaches like continuous assessment and classroom assessment techniques. Advanced learners are mentored and given individualised learning plans to help them to show their advance and progress. Slow learners are taken care with several prospects like peer tutoring, English language support and special classes.

ICT-equipped classrooms and effective teaching methods help students develop their skills in addition

to their information through lecture hours. Resources created by teachers are made available to students for hands-on learning opportunities. In addition to conventional teaching techniques, emphasis is placed on student-centered approaches including experiential learning, participatory learning, problem-solving skills, and case studies, which allow teachers to adopt new methodologies in imparting knowledge.

The academic activities of the institution follow the academic calendar, which informs Faculty and Students of important dates, events, and information about upcoming examinations and all academic process schedules. The college's Examination Management System is supported with IT integration software and significant transformation in examination procedures and assessment procedures such Continuous Internal Assessment, which has significantly improved the system's effectiveness and accuracy.

The Programme outcome and Course Outcome are explained to students and Teachers and are also displayed in the college website. The course outcome attainment enables to evaluate the attainment of POs and PSOs. Analysis of Outcome Attainments lays the ground for further development of the teaching-learning process.

Research, Innovations and Extension

The institution executes clear-cut policies and procedures involving its faculty members, research scholars and students to create a vibrant research ecosystem. The Research and Development Cell of the college provides a platform for innovation and nurtures the research culture by promoting research in newly emerging and challenging areas of Science and Humanities.

Our faculty members have received Rs.5,06,500 for carrying out minor research projects from UGC. Our management provides seed money for faculty members to facilitate basic research work. The college has received Rs.1.04 crore from the Department of Biotechnology for strengthening Basic Science Programmes. A total of 82 faculty members have been recognized as Research Guides under Bharathiar University.

The college has organized 273 Workshops/Seminars relating to Research Methodology, Intellectual Property Rights (IPR), Entrepreneurship and Skill Development. Faculty members are encouraged to publish their research findings in quality and reputed journals, present research papers in National/International conferences of repute in abroad and in India with financial support. A total of 157 numbers of Seminars/Conferences are attended by our faculty members and 433 Research articles are published in reputed Journals. Our faculty members have contributed about 90 articles in Books and Chapters in Edited Volumes and Conference Proceedings.

The institution offers extension activities to the neighbourhood community with the active involvement of faculty members and students of various clubs and forums. As a part of the extension activities, our college has conducted 191 numbers of activities which in parallel contributes to the societal development by involving the NSS and NCC student volunteers.

About 4781 numbers of collaborative learning activities have been undertaken for research, faculty exchange, student exchange, internship, on-the-job training and project work. The college has signed 56 MoUs with organizations and educational institutions of repute for providing training and undertaking collaborative interdisciplinary projects on academic and research related activities.

Infrastructure and Learning Resources

Physical Facilities

The College is situated in a serene ambience of 27.24 acres with an in built area of 433242 sq.ft consisting of 5 academic blocks and separate hostel for Boys and Girls. There are 93 spacious and ventilated class rooms in these blocks with purified drinking water through water doctors in every floor. The college has 22 Laboratories and 12 Computer Labs, Library, Administrative Office, Principal Office, 2 Seminar Halls, 1 Yoga Center, Mini Auditorium with AC, an Open Auditorium and Staff Rooms.

The Library of the College is architected with more than 36731 volumes, 17272 e-books, 195 periodicals, journals and magazines, 5509 reference books, 1260 back volumes, 1456 CD/DVDs along with 17272 online journals and 59 audio-visual resources. Library is automated with integrated Library Management Software in which OPAC facilitates the access to entire Library Database. Digital Repository of the Library provides E-books, E-Journals and E-Database through KNIMBUS. The Library has exclusive collection of books to support students in preparing for competitive examinations.

IT Infrastructure

The College has 800 Computers with a Leased Line Internet Connectivity of 100 Mbps bandwith on 24X7 along with Wi-Fi facility. 29 CCTV Cameras are installed in the campus. Centralized 10 server systems for networking and data processing with upgraded well maintained storage needs.

Sports Facility

The college facilitates sports activity by providing the required infrastructure to conduct sports events like Cricket, Volleyball, Basketball, Ball Badminton and Kaabadi. The Indoor Games such as Carom, Table Tennis, Chess, and Shuttle are also provided to the students.

Laboratory

The College has 22 Laboratories and 12 computer labs equipped with the necessary hardware and software and leased line of 100 mbps bandwidth to provide internet access to the students.

Transport

The College operates 50 buses to fullfill the travelling requirements of the faculty members and the students in and around Erode to the College

Student Support and Progression

The college has provided Management Scholarship of around Rs.3.25 crores for the students during the last five years.

Skill Development

The college takes special care in upgrading the skills of the students by conducting various capacity

development activities like Yoga, Personality Development Programme, Awareness Programme and Soft Skills. The training and placement cell and career guidance and counselling cell of our college conducts programmes to assess the students in enhancing their skills and knowledge to appear for competitive examinations. 90 number of programmes were organized during the last five years. The College takes suitable measures to address the grievance of the students with the guidance of the statutory/ regularity bodies.

Students Progression

The Training and Placement Cell of our college serve as the nucleus for providing the success rate of the OBE by fetching them more opportunities for placement. On an average of 20 percentage of the outgoing students have been placed during the last five years. Totally 114 students qualified in various States/ National level examination during the last five years and 430 previous graduation batch students have joined higher studies in various institution. Around 250 students have brought accolades to the college by bringing in various awards / medals for their outstanding performance in sports / cultural activities at various higher learning institutions. To showcase the talents of the students our college conducted 120 competition during the last five years.

Alumni

The alumni association of our college has been registered and meetings are conducted for effective direct communication of the alumni with the successors laying a stable path for their overall growth and development of the college as well.

Governance, Leadership and Management

The Vision and Mission of the college are taken as the prompt path for all the academic endeavours. It is evident for the clarity of action and effective leadership. College promoted decentralized participatory management in academic and administrative activities and strategic planning. The faculty members are also involved in the formulation of the plans and implementation. Feedback from the stakeholders are considered at the time of taking important decisions regarding the change in the curriculum. Incorporation of innovative methods in teaching and research activities for enhancing the quality of education is an important concern for the college to bring about the overall development of the students. The College has well designed institutional policies for the smooth functioning. The College has implemented E-Governance in the areas of the operations like Administration, Finance and Accounts, Students Admission and Support and Examination. Various welfare measures are taken for the benefit of the staff of the College in addition to the mandatory requirements. The Management extends financial support for the faculty members to participate in the conferences and seminars and present paper in various other higher learning institutions. The college conducts Internal and External Financial audits regularly to ensure the fulfilment of statutory requirements.

The IQAC plays a significant role in organizing various committees to monitor and review the academic progress of our college thereby assuring quality education to the students. The adoption of novel methods in teaching learning process with integration of ICT tools is constantly encouraged through various Workshops, Hands on Training, Seminars and Faculty Development Programme which are organized periodically in association with different committees of the College. The Cell collaborates to implement quality initiatives with other institution and also support the College for participation in NIRF and helps for ISO certification.

Institutional Values and Best Practices

Various programmes are organized by the college to promote gender equity, environmental consciousness, human values and professional ethics. The promotion of universal values and ethical culture are strengthened by the college among the staff and students through the commemoration of important days like World Environment Day, Teachers Day, Youth Enlightenment Day, International Yoga Day, Women's Day etc., To ensure environmental impact, several initiatives have been taken through organizing seminars, workshops, guest lectures and arranging industrial visit for students.

The College is situated in a green environment pervading with large number of trees and grass lands. Energy conservation strategies like the use of LED lights and solar heaters in the hostels and staff quarters are also implemented and conservation of water resources through rain water harvesting is done. The College adopts waste management system for the proper disposal and reuse of to cover solid waste and liquid waste. The college regularly undertake numerous initiatives for conducting various activities in order to facilitate intellectual and psychological development of the students. The institution is very particular in moulding the students as responsible citizens through various programmes which encapsules physical, emotional and social development of the students. One of the best practices followed by the Institution is providing opportunities for digital learning in every sphere of academics. Value Added Courses, publication of books by the students and college bazaars are some of the best practices followed. The College gives great emphasis on the overall development of the student by bringing about required changes in the curriculum there by strengthening their employability skills. Courses incorporating the contents relating to gender equity, environmental consciousness, research, ethics, human values and professional ethics are provided to the students to help them acquire the importance of Institutional and Social values.

DBT Star College Scheme provides experiential learning for the students of Science stream. Entrepreneurship Development Cell inculcates entrepreneurial spirit and culture among the students. Institution Innovation Council (IIC) encourages inspires and nurture young students by supporting them to work with pre-incubation ideas and transform cognitive abilities.
4. Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course):	Our college offers a range of initiatives to promote the development of Indian knowledge systems. These initiatives include an introduction to Yoga, Environmental Studies, Value Education, and Gender Sensitization, all of which aim to shape future leaders. 

Assessment of learning Levels

Accomplishment of vision and mission in conjunction with the proficiency of the Faculty members and their personalized attention in grooming each and every student is the prime objective of the institution.

The institution assures the ambience of continuous improvement in nurturing the students to be globally competent and morally valuable with the signature of excellence. Assessment of students' potential are carried out at several stages right from their day one in the premise.

Stage- I Primary Scholastic Assessment

- The first level of assessment upon students' communication ability, comprehending ability and understanding over their specific discipline is done with diagnostic test conducted based on the syllabus taught during Bridge Course
- All the departments schedule their bridge course training upon the key subjects that were learnt by the students in schools, for a week, in order to strengthen the base for further learning.
- Effectiveness and active participation of students during bridge course is attained through training sessions of Orientation Programme organized on the first three days of students' entry into the premise with a vision of harmonizing them with college environment

Stage-II Secondary Scholastic Assessment

- Second level of scrutiny is made based upon the performance of the students in their Internal Examinations
- Students are categorized into Advanced and Slow learners based on their marks above 70% and below 30% respectively.
- Individual attention is paid to groom them with regard to their own potential.

Advanced Learners

The academic activities assigned to the advanced learners nourish their holistic development.

- The spirit of exploration among the advanced learners is stimulated through Industrial Visits, Extension activities, Institutional Training Programmes and Field Visits.
- The prime quality of observance and inquisitiveness of the advanced learners are fed through encouragement towards their participation in academic lectures, seminars, conferences, workshops outside the classroom walls
- Advanced learners are given an opportunity to undergo extra credit courses to expand their domain knowledge and further motivated to pursue Swayam and MOOC courses which actually groom their self- directed learning.






Figure 2.2.1(a). Strategies for Advanced Learners




Figure 2.3.1. Student Centric Learning Methodologies




Figure 2.3.2. ICT in Teaching – Learning Process

Planning

Academic Calendar




Figure 2.3.4. Academic Calendar Planning and Execution

Response:

IT Integration and Reforms

Challenges test the true potential of an individual. The examination system of the institution ensures a healthy ambience of challenges among the students' community along with an opportunity to compete and excel.

Since examination exists to be the consummation of learner centric methodologies practiced inside the classroom, the institutional practice of examination and evaluation do not tend to be a mere grading system but an assessment of individual student competence in accordance with the growing demands of industry and society.

The institutional success of the examination system attains its prominence due to promptness and accuracy.

Promptness

- The generalized schedule of exams is placed well in advance and circulated through the academic schedule at the beginning of the semester and through academic calendar at the beginning of the year itself
- Notification for payment of exam fees and the application is carried out in two months duration of time before the commencement of theory exams
- Question paper is collected from setters and examined at the scrutiny board in advance with a span of 21 days before the onset of theory exams
- Hall tickets are issued at the assessment of eligibility within the stipulated time promptly
- Continuous Internal Assessment (CIA), Model Exam and End Semester Exam (ESE) are carried out punctually in a scheduled time with better efficiency
- Strict adherence to fixed time limit of 3 hours and 2 hours for ESE and CIA grooms confidence and

the ability to work and think well in competitive and pressured environment among the students

- Valuation is carried out and completed in nominal days and the result gets published in nominal duration
- Announcement for revaluation application and its succeeding process gets completed within next 15 days of time limit from result declaration
- Notification for supplementary exams is given out with a due conscience of time limit that literally benefits students to pursue their academic progress further without any hindrance

Accuracy

The institution always aims at complete accuracy in all its academic activities and the utmost degree of authenticity in examination system and assessment. Exactness of data is enabled through COXCO software.

- The software is technically well built to assist all sorts of examination activities from the beginning to the end
- The details of the programme, course, course code, faculty handling the course, students' details (including the transferred and rejoined students), the grade points of the courses are all fed in the software with extreme care as the very first step of the process. The details of the question papers setters are also scheduled in advance
- COXCO User Id and Password are circulated to all the faculty members and its summary report is also generated and recorded for further reference
- Staff members use their respective Id to enter marks periodically at the end of CIA and Model Exams.
- In End Semester Examination, both the internal and external examiners are facilitated to enter the marks by themselves in COXCO at the selection of their names and institution along with the names of the Chief Examiners and their Institution
- The necessary details along with students' dummy number being fed already in the software helps in easy access with greater accuracy
- The consolidated report of CIA, Model and ESE along with the analysis of pass percentage, absentees, the average marks along with highest and lowest marks awarded by the faculty members for the particular course is produced with high veracity
- The report of result published, the list of students awarded with Consolidated mark sheet, Provisional and Degree Certificates are processed precisely through the software in a short span of time. Results are published in college website for students' notice
- The summation report of action series inclusive of exam fee collection, students' fee payment status, hall ticket generation for the eligible candidates, hall order with seating arrangements and the attendance sheet of the students during ESE are created impeccably with the software
- The schedule of the important dates notably commencement of practical and theory exams, evaluation dates, result publication, application dates for revaluation and supplementary are generated unerringly in COXCO

The effectiveness of the software and its maintenance could be evident through consistent follow up and prompt response to questions posted in query portal.




Figure 2.5.3. IT Integration in Examination Management System

The Departments exclusively frame Programme Specific Outcomes (PSO) and Course Outcomes (CO) based on the demands of academic and career challenges. All outcomes are placed in the Statutory Bodies meet for approval through Curriculum Development Cell and for further approval in Board of Studies of the respective Departments. Outcome Based Curriculum has been introduced in the Institution for all the programme of Arts and Science disciplines separately. Besides five COs for each course, their relationship matrices with POs and PSOs are also formulated.




Figure 2.6.1 (a) Graduate Attributes

Framing of Outcomes

Programme Outcomes of the college are designed distinctly for Arts and Science streams at both UG and PG level based the suggestions of Academic experts. Several Graduate Attributes notably Critical Thinking, Effective Communication, Social Interaction, Effective Citizenship, Ethics, Environmental Sustainability and Self Directed Life Long Learning have been prescribed to be the POs of all the Programmes.

Programme Specific Outcomes, the expected efficiency over specific skills with relevant to the domain area of individual Departments are formulated at the unified efforts of Head of the Department and Faculty Members

Course outcomes are designed based on the expected productive applicability through the implementation of knowledge in particular course. The COs are drafted in relevance with the syllabus by the faculty members in discussion with the Head of the Department, which is then adopted in the curriculum with the concurrence of the Board of Studies.

OBE Monitoring Committee

OBE Monitoring Committee has been constituted to monitor the implementation of OBE in the Institution. The OBE Monitoring Committee reviews the PSOs, POs and COs on a regular basis through discussions. It analyses the improvement in the attainment of each programme, suggests improvement action plans and revises level of targets by means of Action Taken Report (ATR). It also monitors the successful implementation of the ATR to ensure further efficiency. The teachers are encouraged to participate actively in seminars, FDPs, workshops and curriculum meetings, related to outcome based education organized through IQAC in association with OBE Monitoring Committee.




Figure 2.6.1 (b) Dissemination of OBE in the Institution



2.6.2 Attainment of programme outcomes and course outcomes are evaluated by the institution.

Response:

Attainment of programme outcomes and course outcomes are evaluated by the institution.


Outcome-Based Curriculum has been introduced for all the programmes since the year 2017-2018. Seven POs and five PSOs have been framed for each programme of Arts and Science streams separately. Besides, five COs have been drafted for each course, and their relationship mappings with POs and PSOs are measured.



To measure the attainment of COs, the question papers for both Continuous Internal Assessments (CIA) and End Semester Examinations (ESE) are framed as per the guidelines of the revised Bloom's Taxonomy. The marks secured by the students in both the components are recorded and evaluated. The performance of the students in all the semesters provides the overall outcomes by the end of the programme.

OBE is implemented in the Institution with direct Assessment method and the procedures are as follows:

- 1. Method of measuring attainment of COs
- 2. Method of measuring attainment of POs and PSOs
- 3. Action Taken Report



Method of measuring attainment of Cos

The course instructor knows the target of course outcome to be attained for the particular course which is being taught. Questions are set at the appropriate Bloom's levels in the internal, model and end-semester examinations. Bloom's levels are indicated for each question in CIA Test I, CIA Test II, Model and End-Semester Examinations. Recorded data which are arrived at examination results are analysed to check the level of outcome attained by each course. Rubrics for direct assessment are framed by the OBE monitoring committee and disseminated to the faculty members for the follow-up. In direct assessment, the formative and summative evaluation is assessed on the basis of 25:75 ratios respectively. From the academic year 2021-2022, the ratio has been changed as 50:50. The formative assessment consists of two internal exams, one model exam and two assignments for UG / two seminars for PG students.

Method of measuring attainment of POs and PSOs

The course outcome attainment enables the assessment of POs and PSOs attainment. The attainment of each of the PO and PSO from the course outcomes have been measured by means of a relationship matrix mapping method.

All the outcomes are measured for each programme and the attainment level is graded as high, medium and low. Mapping of COs with POs and PSOs provides the correlation in which the level **3** signifies the **high** attainment level, whereas **2 and 1** signifies **moderate** and **low levels** respectively. Efforts are ensured to move towards high scaling till the fixed attainment level. The assessment grades are further revised in

the case of attainment of high level at the end of the programme for the constant pursuit of betterment.

The Institution adopts the following assessment methodology to evaluate the outcomes and the relationship matrix of COs, POs and PSOs.

Action Taken Report

Based on the attainment level, Action Taken Report (ATR) is planned as follows:

- If attainment is less than the target level, then improvement actions are planned.
- If attainment meets the target level, then the cut-off percentage will be increased.

Thus, through the attainment of COs, POs and PSOs, an evidence based demonstration is presented that the concerned programme has achieved better attainments in the outcomes and strive to continuously improve the attainment for the succeeding batch of students.

3.1 Promotion of Research and Facilities

3.1.1 The institution's Research facilities are frequently updated and there is a well defined policy for promotion of research which is uploaded on the institutional website and implemented

Response:

Research and developmental activities carried out in Kongu Arts and Science College creates and disseminates new knowledge in various fields and promotes innovation to motivate better learning and teaching among faculty and students.

The **Research and Development Cell** of the college shall be responsible for preparing and implementing the research policy by working closely with the college Management. The purpose of the Research Policy is to create a vibrant atmosphere for research among faculty and research scholars in our college. The policy shall serve as an overall framework within which research activities may be carried out. The **code of ethics** augments to create awareness on ethical conduct of research, promotion of academic integrity and prevention of misconduct including plagiarism in academic writing among students, faculty members and research scholars.It is ensured that each member involved in research will adhere to highest ethical standards of conduct by maintaining data integrity and ethical guidelines.

Research Advisory Committee and Ethics Committee are constituted under the chairmanship of Principal involving coordinators, internal & external members and academic experts from our college and other colleges to co-ordinate with the research activities of the college. The Management creates a conducive environment to carry out research by providing suitable infrastructural facilities and funding seed money based on the merit of the proposed research.

Faculty members are encouraged to publish their research findings in reputed journals to present research papers in National/International conferences of repute abroad and in India with financial support and to apply for recognition as research guides. The college frequently organizes seminars, workshops and training programmes to facilitate the development of domain knowledge in relevant fields. Moreover the faculty members are encouraged to undertake research by collaborating with sponsoring agencies.


The college encourages research by providing infrastructure through **Research Incubation Centre** in the campus, in which the scholars can utilize the central instrumentation facility. Research and Developmental activities are undertaken in various areas namely genetic engineering, microbial biotechnology, nanotechnology, textile finishing, material science, solid state ionics, thin film technology and computation. The equipments such as UV-visible spectrophotometer, Transilluminator, Digital fluorimeter, Electromagnetic stirrer, Gel casting unit, Centrifuge, Soxhlet apparatus, Bacteriological incubator, Digital colorimeter, Padding mangle, Launderometer, Hot air oven, Perspirometer etc are available for carrying out research in the **Central Instrumentation Facility** of our college.

Higher standard of academic excellence is met with the financial support under DBT Star College Scheme which provides support for developing infrastructure for academics and laboratory activities. This support invigorates teaching and provides unique exposure of students to experimental science.

Every year new books related to research are added and subscriptions to journals are renewed in library.

The institution has membership in Delnet, Inflibnet, e-ShodhSindhu and British council. College library provides access to N-LIST (the college component of e-ShodhSindhu), Databases, Shodhganga, e-books and e-journals. Knimbus is a cloud based digital platform that enables the users to access e-resources from any location.

At the end of each academic year, the Management honors the faculty members who have contributed to research by publishing research articles in Scopus/Web of Science journals and undertaking sponsored research projects on 'Achiever's Day' celebrated by our institution. A high level of efficient support system is ensured to facilitate faculty members and research scholars to carry out their research activities effectively.


Funding Development Cell (FDC) aims at receiving grants from recognized government and nongovernment research funding organizations by promoting research in newly emerging and challenging areas of Science, Arts and Humanities. The FDC is encouraging, motivating and guiding the research scholars and faculty members to undertake various major/minor projects and to conduct sponsored seminars/workshops/conferences from various funding agencies to take up research in upcoming areas of multidisciplinary fields. The cell creates awareness and opportunities in funding projects and research among the research scholars and faculty members in relevant discipline

The **Entrepreneurship Development Cell (EDC)** conducts workshops and awareness programmes which helps the students to think innovatively and assists them to become entrepreneurs. Innovative Business Idea competition is conducted for the students to develop their creative thinking potentials. The cell organizes Entrepreneurship Talk Series inviting eminent entrepreneurs from various fields to motivate students to develop their own start-ups.

The **Intellectual Property Rights Cell (IPR Cell)** is formulated to cultivate the culture of innovation among students. In addition, the cell motivates and guides the faculty members and students to get their novel innovations and inventive step to get patented. The IPR Cell organizes seminars, workshops, contests and various students related activities regarding intellectual property.

KASC Science Forum regularly conducts numerous programs to nurture innovativeness and to enhance scientific temperament among the students. It provides opportunities for students to carry out self directed activities in areas of interest in science. The forum also helps the students to develop a scientific way of learning and to acquire skills in fieldwork, research and project presentations.

Institution's Innovation Council of our college imparts knowledge to generate ideas by conducting the programmes suggested by the Institution's innovation Council of Ministry of Education. It inculcates innovation, start-up, and entrepreneurship to the stakeholders of the institute through defined academic activity. It offers start-up supporting mechanism, establishes function ecosystem for scouting ideas and pre-incubation of ideas and develops better cognitive ability among students. 3.6 Extension Activities

3.6.1 Extension activities are carried out in the neighbourhood community,-sensitising students to social issues, for their holistic development, and impact thereof during the last five years

Response:

The institution offers extension activities to the neighbourhood community with the active involvement of faculty members and students of various clubs and forums. These clubs and cells often meet the members of the local community through their scheduled programmes.

The **National Cadet Corps** (**NCC**) was established in the College in the year 1999 for Senior Division and in 2003 for Senior Wing with the motto of Unity and Discipline. The NCC cadets are trained perfectly to impart leadership quality. They play a significant role in maintaining discipline among the students during the functions conducted in the college. The NCC students are motivated to participate in social activities like Tree Plantations, Blood Donation, Fitness Awareness Rally, Road Safety Awareness Programme, Awareness on Plastic Waste Management etc. The NCC unit has conducted a Plog Run Event for creating awareness on Clean India and a Seminar on 'Drug Abuse and Illicit Trafficking'.


In our College, four National Service Scheme (NSS) units are effectively functioning on being lead by

energetic programme officers who are instrumental in organizing extension activities in the adopted villages. A seven day camp is organized by NSS units every academic year where the NSS volunteers stay in the adopted villages and serve the community. The NSS units organize extension activities like Health Awareness Rally, Disposal of Plastic Wastes, Cycle Rally, Blood Donation, Tree Plantation, Fundamental Rights Awareness, Conservation of Nature and Tribal Welfare Programmes. In addition, under Unnat Bharat Abhiyan (UBA) Programme (a flagship programme of MHRD, Govt. of India), NSS has received a fund of Rs.50,000/- to conduct survey in the adopted villages and awareness sessions to the people. The NSS team has established facilities worth Rs.1,50,000/- in the adopted villages. The NSS volunteers create awareness among students to celebrate and commemorate National and International events to understand the values of nation and society.

Apart from NCC and NSS units, the **various departments** of our college conduct extension and outreach activities in the nearby community through programmes like donation of stationery items, donation of garments, environmental protection and imparting skills to neighbourhood school students. The students from the Department of Social Work involve themselves actively in community by conducting various programmes like Rural Welfare Camps, Tribal Welfare Camps, Awareness programmes, rallies and skits on Autism, Female Infanticide, Breast Cancer, Organ Donation, Elder Abuse, Disaster Management and Solid Waste Management.

Our College Management offered both Boys' and Girls' hostel with necessary facilities for **COVID Care Centre** during pandemic period to improve the lives of those affected. Our college associated with the District Administration team for social contribution towards the society by providing nearly 500 bed facilities for COVID Care along with Siddha treatment.

Youth Red Cross unit functions with hundreds of volunteers in our college. The main purpose of YRC is to inculcate health awareness among the youth. The **Red Ribbon Club** is functioning at our college in collaboration with Tamilnadu State Aids Control Society to create awareness about HIV/AIDS among the students. Blood Donation Camps are organized once in a year.

Criterion 4 - Infrastructure and Learning Resources

4.1 Physical Facilities

4.1.1 The Institution has adequate infrastructure and physical facilities for teaching- learning. viz., classrooms, laboratories, computing equipment etc.

Response:

PHYSICAL FACILITIES: Teaching – Learning Process

Kongu Arts and Science College provides a conducive environment and adequate infrastructure facilities for the existing academic programmes, administrative functions, co-curricular and extra-curricular activities.

The institution amplifies physical and technological infrastructure as per the minimum requirements specified by the statutory bodies, viz., UGC, AICTE, TANSCHE, and Bharathiar University. The teaching and supporting departments are accommodated in five (5) separate blocks with a total built-up area of 27.24 acres of land and a total constructed area of 4, 86, 852 sq.ft. The infrastructure and other facilities in the college adequately support the teaching and learning process for 4057 students enrolled in 23 UG and 11 PG programs.

Classrooms

The college has five academic blocks comprising 93 classrooms designed as per the safety guidelines prescribed by the statutory authorities. The classrooms are spacious, well-furnished and equipped with adequate teaching and learning facilities.

Laboratories

The subsequent 34 Laboratories are facilitating the students in their respective domain areas. Computer Labs (11), CAD Center (1), English Language Lab (1), Ramanujan Lab (1), E-Learning Lab in the Central Library (1) with internet access (100 Mbps), Costume Design & Fashion labs (6), Biochemistry labs (3), Biotechnology lab (1), Catering Science & Hotel Management labs (8), Physics lab (1).

Skill Centre Type Writing School

Kongu Type Writing School is established with the view to improve the employability of the Students and thereby providing an additional technical skill.Students can attend the classes and appear for the Technical examination conducted by the Government of Tamilnadu through the typewriting school.

Seminar Halls

The institution has well-equipped and air-conditioned seminar halls with the following names: U.V. SwaminathaIyer Hall and PG Seminar Hall, which are used to conduct college committee meetings, seminars, conferences, workshops and various departmental functions respectively.

Offices and Cells

The institution has well-furnished Correspondent and Principal chambers, Administrative office, COE office, Examination cell, Training and Placement cell, Career Guidance and Counseling cell, Research cell, ISO-AMR office, Transport office and IQAC.

Yoga Center

The Yoga Center provides beneficial strategies for the mind, body and soul. A separate yoga centre is available in Ramanujan Hall, with a floor area of 1920 square feet. Yoga sessions are regularly organized in the yoga center. Certified yoga instructors are invited to the college to train the students.

Examination Cell


A separate examination Cellis available with a floor area of 21,635 sq. ft. for conducting examinationrelated activities in a confidential manner with essential security arrangements. The infrastructure of the examination cell includes valuation and section halls, separate rooms for controller, assistant controller, scrutiny, question paper printing, dummy number allocation, valuation paper storage, record, stock, office and strong rooms. The automation of examination process has been done through COXCO maintenance software.

Library

Knimbus, the Digital Library Portal, has fully automated central library. The library has a floor area of 7,216 sq. ft. and is stocked with 17,831 titles, 31,222 textbooks, 5509 reference booksand 122journals, including 28 international journals, magazines, and digital resources with internet and scanning facilities.

English Language Lab

To enhance students' communication skills, English language lab is equipped with an overhead projector, desktops, laptop with a projector screen, microphones and speakers with audiovisual aids to improve listening and speaking skills.

Cultural Activities

The Fine Arts Club encourages and motivates the talented students to participate in various cultural events. Talent Hunt conducted in the Institution helps to identify and exhibit the talents of the students with adequate training to take part in the cultural competitions. Culture related festivals are celebrated with traditional fervor and enthusiasm.

The open auditorium in the college provides a platform for the students to showcase their talent in the 'Kongu Cultural Fest' organized by the institution. The library is mechanized by utilizing Integrated Library Management System (ILMS):

The Teaching Program is largely dependent on the library, which occupies a leading position. It is more than just a place to store books; it is an active workshop tool that helps people come up with new ideas. The library provides self-education opportunities to all who are justifiable and enthusiastic, including faculty members and students. It encourages the acquisition, evaluation and recognition of knowledge in preparation for further education and the learning of new fields. It is a mirror that measures the institution's standards and reflects the culture and activities of the educational establishment.

Library Automation Software:

Library Automation is a recent development in library management that is increasingly being utilized in worldwide libraries.Regular library services and tasks are possible with library automation through barcode scanning; it makes the work simpler to identify 36,631books.Our Library is mechanized with Circulation, Cataloging,Acquisition and Serial Control.The LIBA SOFT, OPAC, and KNIMBUS Digital Library Portal and LLIPS connects Net 12.0 are also used to automate it.

The Library Automation Software contains 3 modules, viz, LIBA SOFT, Library WEB OPAC, and E-Gate Register.

OPAC (Online Public Access Catalog)

OPAC is an extremely helpful device for students and employees to look for the accessibility of a particular book. OPAC gives full details of book issued date, person's detail, the due date of return and so forth. It also helps to identify the section of the library's rack for particular book instantly.

Library OPAC (Online Public Access Catalogue on the web) is a separate module, which helps the user of the library to search the Title, Author, Publisher and Access. No. etc., it is also available to reserve the books or cancel the reserved book inside/outside the campus. He/she can check out his/her dues and overdues in the library. There is a way to download digital clips and print out some of the content. Library resources are made available for users with restrictions.

E – Gate

E – Gate Softwareavailable at the entry point of librarymanages the entry and exit of users while scanning their id cards to record their visit to the library. The user's time-in and time-out entries are recorded to the e-gate register and the software also supports Multi - E - Gate option. Accordingly, user's activities can be monitored by keeping systems in Reference Section, Periodical Section, Back Volume Section, Reading Section, etc.

Knimbus

Knimbus is a cloud-based digital library platform which enables to access the entire digital content at anytime and anywherein any device through a single platform and single login.

Knimbus Library Portal addresses the key points of the Institution Library:

- Knimbus Library Portal makes it easier for people to use e-resources because it can be used at any time and from any location. It is a simple, secure way to put all e-resources in the user's pocket.

The college has developed guidelines to maintain and to use academic, supporting, and other physical facilities.Utilizing the college's facilities and resources more effectively is made simpler by the policies.

Maintenance and Utilization of Physical Facilities

The College Building:

The college's green environment is clean and well-kept. The Campus Maintenance Committee is in charge of maintaining and making use of the actual infrastructure. The Campus Maintenance Committee receives assistance from security personnel, gardeners, electricians, and attenders. In accordance with the requirements of the day, the restrooms on each floor are cleaned frequently. The physical infrastructure is checked on from time to time and necessary repairs are made. The procedures are established to ensure all the Classrooms, Computers/Networking Components, Instruments/Equipments and associated peripherals are in good working condition.

- The constituted Campus Maintenance Committee supervises the maintenance of all physical infrastructure in the college
- Sufficient number of housekeeping staff are available to sustain the cleanliness of classrooms, toilets and other rooms regularly
- Periodic stock verification is carried out by assigned team members
- Electrical appliances and fittings are regularly checked and replaced whenever necessary
- The calibration and servicing of equipment are done periodically

Sports Facilities:

The Department of Physical Education is responsible for the maintenance of the sports facilities which includes the basketball court, volleyball court, gymnasium and the indoor games kit. The Sports Director works with a Sports Assistant who, in turn assisted by attender regularly cleans the sports grounds and equipments. Qualified coaches are appointed for basketball, cricket, volleyball, softball and football for interested students. The gymnasium equipmentare frequently cleaned to ensure that the students enjoy these facilities to the maximum.

Procedure for Sports:

The procedures to ensure the utilization of sports infrastructure

- Periodic reviews over the progression of sports activities by the sports committee.
- The college sports infrastructure is utilized for conducting various University, District and Zonal level sports meet apart from the regular sports activities.
- Sports Students utilize the sports materials/equipment are available in the Physical Education Department as per the norms.

Maintenance and Utilization of Academic and Support Facilities

Laboratories:

The equipments for laboratories are purchased with the approval of the Managementand Purchase Committee. The laboratories in charges take complete responsibility of the maintenance of all labs respectively. The periodical maintenance service is provided to all the equipments. Chemicals and other equipments are purchased and maintained as per the demand.

System Maintenance and Administration:

The Systems Manager and Programmers are responsible for the maintenance and utilization of the Computer Laboratories. They resolve hardware and software-related issues, maintain ICT facilities, supervise the electronic equipment service, maintenance of printers, scanners, LCD projectors, audio-visual equipment, etc..The Computer laboratories equipments are periodically serviced to ensure its efficiency.

Classrooms:

All the classrooms are upgraded every year including the repairing of furniture and repainting. Every classroom has a waste disposal bin that is emptied and cleaned every day. The ICT used in classrooms are regularly serviced to ensure smooth execution of teaching-learning process. Cleaning of the green boards, classroom furniture and floors are done every day.

Electrical Work:

Maintenance of electric infrastructure is carried out by the Electrical Department appointed by theinstitution. The electricians are qualified to conduct all the works essential for providing uninterrupted power supply to the entire campus.

Library:

The Chief Librarian is responsible for the maintenance and utilization of the Library. The Librarian is assisted by the assistant librarian and library staffs. The library has established procedures for the purpose of maintaining books, magazines, DVDs and manuscripts. Books have been purchased as per the demand of the curriculum and periodical maintenance is also carried out regularly. Books and Stock verification process is done at the end of the academic year. The unique code of the identity card validates the entry and exit of the library users. The damaged books are periodically replaced with new ones. The computers and software are updated as per the demand with proper maintenance procedure. The Library policy comprehensively covers the management of all aspects of the library. The supporting staff renders its services to the library to keep the premises clean.

Women Development Cell conducts skill-oriented programs for the empowerment of female students in which the student-executives involve in organizing the programmes.


Science Forum:The students actively are involving in the science projects as well when the programmes are organized for the school children or other institution students, our students are helping them to organize the programmes.

Nature of Governance

Kongu Arts and Science College (Autonomous) (KASC) is one among the seven educational institutions of Kongu Vellalar Institute of Technology (KVIT) Trust, established in the year 1994. The Institute has been continuously ranked by several reputed publications such as India Today, Education World and Outlook among the top 100 Colleges of India. Under the guidance of eminent trustees, with a unified vision of social upliftment through educational enhancement and several other bodies, the institution marches steadily towards its vision and mission.

Governing body strengthened with the alliance of Secretary of the KVIT Trust along with the Correspondent and Principal of the College, stays ever ready to implement the actions that demand the welfare of students, teaching and non-teaching staff members. Academic body with the team of Principal and Heads of the Department ensures academic excellence through Curriculum Development Committee, Board of Studies, Standing Committee on Academic Affairs and Academic Council meetings periodically.

Internal Quality Assurance Cell is responsible for ensuring quality in all the academic activities of the College. IQAC, in troupe with Controller of Examination assess the academic quality control with consistent curricula and pedagogic upgradation, research progress and other initiatives.

The Principal regularly monitors the academic and the administrative functions of the institutions to ascertain the quality. HoDs' Meeting is conducted at regular intervals. Periodic review meeting of the faculty members with the Principal helps in minimizing the distance of travel towards institution's vision and mission. Staff club meetings helps in creating good rapport between the management, teaching and non- teaching staff community.




In consultation with the IQAC, the college prepares the Strategic/Perspective Plan. The following are the major areas focused.

By virtue of the role played by the teachers in decision making bodies and through effective governance, the College produces students who are skillful, dynamic and ethical in rendering their duties to the society thus achieving the vision and mission of the College.





6.1.2 The effective leadership is reflected in various institutional practices such as decentralization and participative management.

Response:

Decentralization and Participative Management

Decentralization and participatory management are the key to the organization's collective leadership and democratic values. This is reflected in the extensive delegation of power to department heads. The Institution empowers the Heads of the Departments to take administrative decisions related to the Departments following the guidelines of the institution. HOD has the power for making various decisions like Time Table, Placement, and Progress of the students. To oversee the effective functioning of various operations in the institution, the various functional bodies are formed such as statutory, non-statutory and committees.

Senior faculty members of the institute were alone empowered and nominated as coordinators for the various functional bodies. All faculty members, even at entry level faculty members are given independent

responsibilities like faculty member in charge of laboratory, class in charge, student mentor and others. Department level faculty meetings are held periodically to discuss all matters of academic, administrative and infrastructure development. The Principal convene periodic meetings of the Heads of the Departments and various coordinators to arrive at major decisions. Budget preparation starts from the laboratory level in which the faculty in charge of laboratories raise the budget required which are consolidated by Heads of the Departments for finalizing the budget for the department. Faculty members have due representation in Board of Studies, Academic Council, Internal Quality Assurance Cell, etc. The Institution adapts decentralization strategies to bring out transformational leadership in faculty.


Case Study: Value Added Courses

The College management has given autonomy to KASC Academy of Excellence (KASCAE) to plan and execute the value added courses every year. Senior faculty member is appointed as the Convenor of the KASCAE by the head of the institution. The heads of various departments appoint the department coordinators to run the courses. The Convenor along with the various department coordinators finalizes the Value Added Courses which have been designed to identify, groom and to acknowledge the individuality of the students in their field of interests.

The KASCAE provides around 40 courses and coaching for two Professional Courses to students, which develop their skills in interdisciplinary arena, that in turn supplement their degree programs and employability. The duration of each course is 40 hours, carried out in addition to normal working hours. Student counselling sessions are arranged through online/offline mode to select the Value Added Courses. Classes are conducted after the enrollment. Students are appraised through both Practical and Theoretical examination and Certificates are issued at the successful completion of course by the students.

Gradual increase in Placement through Professional courses and trainings, Entrepreneurship start-ups, Awareness on Health and Hygiene, Social Accountability, Digital Competence and Passion for Cultural Pursuits evidence not only the accomplishment of industrial needs but also the holistic development of the students.

VAC walks an extra mile through MoUs with TCS and Infosys Companies by the Training and Placement Cell, in accordance with few courses to bridge the gap between Campus and Corporate and to meet the technical competence of current scenario. The entire process is monitored and managed by the Convenor of KASCAE and reports are submitted to the Principal and Management every year.



6.2 Strategy Development and Deployment

6.2.1 The institutional Strategic / Perspective plan is effectively deployed

Response:

Based on the recommendations of the NAAC peer team in the third cycle of accreditation in 2017, the College has developed a strategic plan for its development. The Strategic/Perspective Plan of the College is the guiding framework for activities and initiatives planned by the Departments and all individual members

of the staff. Strategic Planning and deployment document is based on analysis of current obstacles and future opportunities and envisages the direction towards which the organization should move to achieve its set goals and objectives. The IQAC has implemented many activities successfully which is described in the Strategic/Perspective plan and one among the fruitful activity is establishment of Intellectual Property Rights Cell.

IPR (Intellectual Property Rights Cell)

With rapid technological advances taking place worldwide, many inventions and creations have become a daily affair. Most of these that have shaped our life, have roots in laboratories of educational institutions. Inventions and creations are considered as property of intellectual in nature and there are laws across the globe to prevent the use or misuse of the invention other than the original inventor. In this regard, IPR Cell of the college was constituted in February 2021. The aim of IPR Cell is to create awareness and provide guidance to faculty members, research scholars and students on intellectual property rights. IPR cell functions as a separate cell to propagate the importance of IPR among the student and teaching community of the college.

Main objectives of Intellectual Property Rights Cell (IPR Cell) are:

- Cultivating the importance and nature of innovation among students.
- Motivating and guiding the Faculty Members, Research Scholars and Students to get their novel innovations and inventive step to be patented.
- Organizing seminars, workshops, contests and various students' related activities regarding intellectual properties.
- Facilitating the Faculty Members, Research Scholars and Students in transforming the research work into copyrighted and valuable patents.

After the establishment of IPR Cell in the college, 14 patents are obtained in a short span by the faculty members of the Institution.


The organogram of the institution is prioritized with the Governing Body((GB) as the Apex body of the institution. The Governing Body of KASC is constituted as per the UGC norms. The Secretary of KVITT acts as the Chairman of the GB. The GB is given authority with the responsibility of preparing long term goals for the institution and examines the overall performance of the institution. It discusses and approves changes pertaining to academic matters as proposed by the Academic Council.

The Academic Council (AC) is comprised of representatives from all the stakeholders of the institution. The AC scrutinizes and discusses on the academic performance of the institution. It is responsible for the introduction of new Programmes and approves changes to the curriculum, as proposed by the Board of Studies of different departments.

The Board of Studies, consisting of HoDs of the respective department, University nominees, reputed academicians, industry experts and Alumni representatives. The Principal is entrusted with the leadership functions of the institution. The Principal overseas the Administrative Office and the functions of IQAC, COE Office, Examination Section and all other cells.

The IQAC gathers responses from all the stakeholders and initiates quality enrichment measures. The Examination Centre, headed by the CoE, executes general reforms in the examination system to make it more lucid and effective. Various College committees are headed by efficient persons and strengthens the functioning of the college.

6.4 Financial Management and Resource Mobilization

External Audit

Internal Audit

- The income and expenditure of the institution will be verified by the Administrative Officer and the Principal on daily basis.
- Office Superintendent and Accountant will check cash ledgers on daily basis.
- Funds received from various agencies are properly accounted, vouched and verified in the college office and finally checked by the Administrative Officer and the Principal.
- Internal auditor C.Velumani appointed by the Management audits all the financial transactions of the college.
- For the regular maintenance of accounts, the Staff members are also assigned duties

Mechanism for Settling Audit Objections:

The expenses of the college are incurred in accordance with the budget approved by the KVIT Trust every year. All the HODs and other faculty in charges are given power to utilize the funds as per the guidelines with the approval of the Principal and Correspondent. The college is maintaining the internal finance approval system for all expenses is in place. All the vouchers and bills are audited once in a month by an Internal Auditor. The audit objections and report of the internal auditors are discussed in the management committee meeting conducted every month and objections are closed. Books of Accounts maintained in the college are audited annually by External Qualified Chartered Accountants appointed by the Management and the final audited report is discussed in the Annual Meeting of the Management Committee for further actions and suggestions.

Audit for Government Funds

The expenses made from the various grants received from Central, State governments and other funding agencies under various schemes and Funding Sponsored Programme are audited by the Chartered Accountant appointed by the college and relevant Utilization certificate duly signed by the Principal and the Chartered Accountant are sent to the authority concerned.

6.4.3 Institutional strategies for mobilisation of funds and the optimal utilisation of resources

Response:

Kongu Arts and Science College is one of the great possessions of the committed Trust called 'Kongu Vellalar Institute of Technology Trust' in Erode District, Tamilnadu. The noble Trust has taken the institute to greater heights since its inception in 1983 and has established the college as a self-finance college. The mobilization of funds is not an issue, though the college is being managed by a team of 37 philanthropists who are leading industrialist.

Resource Mobilization:

6.5 Internal Quality Assurance System

6.5.1 Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes visible in terms of – Incremental improvements made for the preceding five years with regard to quality (in case of first cycle) Incremental improvements made for the preceding five years with regard to quality and post accreditation quality initiatives (second and subsequent cycles)

Response:

The IQAC frames the quality policies for Teaching-Learning, Research, Curriculum implementation, Student Activities and Progression, Infrastructure and Learning Resources, Innovation, Institution Values and Best Practices and all the extracurricular and co-curricular activities. IQAC executes feedback response from students, parents and stakeholders on quality-related institutional processes and also organizes various workshops, seminars for the promotion of quality in our campus. IQAC acting as a nodal agency of the Institution has identified and implemented many initiatives for institutionalizing the quality in the campus. Out of these, two quality practices have been discussed below.

Practice 1

• Learning Development Cell (LDC)

SWAYAM is a programme initiated by Government of India and designed to achieve the three cardinal principles of Education Policy viz., access, equity and quality. The objective of this effort is to take the best teaching learning resources to all, including the most disadvantaged. SWAYAM seeks to bridge the digital divide for students who have hitherto remained untouched by the digital revolution and have not been able to join the mainstream of the knowledge economy. Accordingly, LDC was established in our Institution.

Learning Development Cell of the College aims to stimulate the students and teachers to learn about SWAYAM and other online courses. It also provides a platform to discover and develop unique skills and talents among the student and teaching community by making them to utilize digital learning resources. As a part of decentralization and participative management, the Cell has been coordinated by the Convener, who is a Senior faculty member of the Institution. The Departments are represented by the department level coordinators who monitor and mentor the students regarding the online course activities. Nearly 600 students and teachers have completed the SWAYAM courses successfully during the last 5 years.

Practice 2

Institution Innovation Cell (IIC)

IIC is a unique initiative of MHRD Innovation Cell and is different from other existing models. It aims at streamlining and strengthening the Innovation and startup ecosystem in HEIs campuses. Accordingly, IIC was established in September 2020 in our Institution.

The Cell aims to promote innovation by providing eco-system in our campus and also by identifying, mentoring, nurturing innovative and entrepreneurial potential of students and transforming them into startup entrepreneurs. The Cell conducts regular workshops, seminars, interactions through successful entrepreneurs and offers a mentoring support for student innovators. The Cell has been awarded 4 golden star certificate for its better performance in the Academic Year 2021-2022.

6.5.2 The institution reviews its teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals through IQAC set up as per norms and recorded the incremental improvement in various activities (For first cycle - Incremental improvements made for the preceding five years with regard to quality For second and subsequent cycles - Incremental improvements made for the preceding five years with regard to quality and post accreditation quality initiatives)

Response:

It has been one of the primary concerns of IQAC to adopt practices, which will provide quality education to the students through an effective and meaningful teaching-learning process. This plays an instrumental role in enhancing the quality of the academic and co-curricular endeavours of the college in keeping with its vision and mission. IQAC achieves this through mainly two practices, viz.,

Example 1

Audit system: External Academic Audit

The Annual External Academic audit is conducted by the IQAC to ensure the effective implementation of the teaching - learning process. The expert members from the Academic audit once in the year visit all the departments to inspect the records related to academics. The Expert committee review the Profile of the department, Infrastructure and academic activities of every department. The assessment of the strengths and weaknesses of the departments are reviewed by the members of the Academic Audit. The consolidated reports of the audit, with suggestions and recommendations, submitted to the Principal are reviewed with the Heads of the departments. It represents a comprehensive view of the teaching - learning process, highlights the best practices of the department and also helps the departments to evaluate their academic standard to move further.

Example 2

Outcome Based Education(OBE)

Outcome based education (OBE) system has been implemented towards strengthening the learning potential of students from the academic year 2017-2018. In this OBE implementation, major deficiencies in the traditional educational system have been eliminated. The main advantages of the OBE are :

Clarity

The focus on outcomes creates a clear expectation of what needs to be accomplished by the end of the course. Students will understand what is expected of them and teachers will know what they need to teach during the course.

Flexibility

With a clear sense of what needs to be accomplished, teachers will be able to structure their lessons around the students' needs. OBE does not specify a specific method of instruction, leaving teachers free to teach their students using any method. Instructors will also be able to recognize diversity among students by

using various teaching and assessment techniques during their class.

Comparison

The clearly articulated outcomes should allow institutions to assess the student's achievements rapidly. A potential employer can look at records of the potential employee to determine what outcomes they have achieved. They can then determine if the potential employee has the skills necessary for the job.

Thus, OBE reforms emphasize setting clear standards for observable, measurable outcomes. It is a studentcentric learning model that helps teachers to deliver the course content and conduct assessment, keeping in mind the intended outcomes of the specific programme. OBE enhances the employability of the students besides helping them to imbibe necessary skills in their personality.



Solid waste management


- A well-planned Waste Management System helps to maintain a clean campus. The college provides separate bins for bio-degradable and non-biodegradable wastes.
- The biodegradable waste collected from the green bins is dumped in a vermicompost pit for

generating organic manure for the gardens. The non-biodegradable waste collected in the blue bin is disposed in a pit. E-waste are collected in red bin for disposal.

- Kitchen waste and vegetable waste from hostel mess and Canteen are processed for Bio Gas Plant to generate bio gas to be used as fuel in the hostel kitchen.
- Wellbeing Out of Waste (WOW), a nationwide recycling initiative of the ITC, is collecting used papers ¬ebooks from the students to improve learner attitudes towards recycling.
- Institution waste papers and Exam papers are collected by a certified Vendor.
- The campus is Wi-Fi enabled and hence all communication is made online minimizing the use of paper.
- Secured Payment Gateway for fee payment.
- E-Publication of results through institution website.
- Online platforms are used in collecting feedback and other academic activities.
- Sanitary napkins are burnt in the incinerators installed in rest rooms.

Liquid Waste Management

- To instruct the student with the exercise of using water proficiently and reducing its wastage, awareness signboards are kept at different places of the campus.
- The waste generated through the RO Plants are collected in the water tanks and used in the rest rooms and for gardening.
- The liquid waste from the Biotechnology and Microbiology laboratories are safely decontaminated in the autoclave and the waste collected from the washing process is sent for recycling into Sewage Treatment Plant.
- Waste water generated from hostel& mess is treated through a **hi-tech Sewage Treatment Plant** (**STP**) in the campus.
- The sludge settled in STP is removed regularly and dried on drying beds. The dried sludge is utilized as manure.



E-waste management

- The E-waste includes the parts of computers, printers, scanners, network cables, servers, monitors, compact discs, copiers, calculators, battery cells etc. UPS Batteries are recharged or repaired or exchanged by the suppliers.
- E-waste which are fully condemned are safely stored in a room and sold as scrap.
- Refurbishment of e-waste outdated computers, used batteries, CPU's, etccollected by OlirumErodu Foundation for disposal.
- The college has signed an MOU with M/s ASCENT URBAN RECYCLERS PVT.LTD for disposal of unused equipment which cannot be reused or recycled.

Waste recycling system

- The college follows the 4 R's technique -Refuse, Reduce, Reuse, and Recycle in waste recycling process.
- The Recyclable wastes such as examination papers are collected and periodically supplied to the local recycling vendors to avoid wastage dumping.
- Biodegradable waste is collected and used as a source for biogas production located in our college campus.
- STP plant helps in recycling liquid waste.

Hazardous chemicals and radioactive waste management

• The campus does not generate any hazardous chemicals and radioactive waste.

- Pesticides for gardens, mosquito repellents and sanitation chemicals for the washroom are used within permissible limits.
- Fume-hoods are installed in laboratories to protect from hazardous contaminants generated by experiments.





The principle goal of conducting X-Travaganza (Exhibition cum sale) is to create entrepreneurs who are capable of doing new things, creative and inventive. Here the students are allowed to develop new products, forecasting the market trends thereby paving an opportunity for them to earn while learning.

The Department of Commerce and Commerce(CA) organizes "KASCO" - an exclusive activity based learning programme which induce the concept EARN WHILE LEARN. The Department of Management Science (PG) organizes FESI (Fun & Earn through Smart Innovation) – A mega sale mela for two days. These activities help the students to develop their interpersonal, Planning, leadership, and Coordinating Skills. Various Stalls had been arranged for the students to inculcate the real time experiences in the field of marketing a product, raising fund and managing fund, and raw material purchase.

The Objectives of the practice:

- To engage the students in activities beyond their curriculum.
- To identify and support those activities that contribute most directly to student's learning.
- To enable the budding designers to have real experience and confidence that can only come from designing and developing new products.
- To provide opportunities for the student to create products they are passionate about and also to earn while they learn.

The Practice:

Exhibitions are valuable because they allow face to face communication and offer opportunities for exchange of knowledge. Students are encouraged to develop new products beyond their curriculum, forecasting the market trends as well. While most of them create attractive new products some of them also act as an intermediate between the wholesaler and target costumers thereby offering retailing also. Faculty members give due attention towards price fixation and care is taken in sorting of products so as to avoid too much of repetitions. Finally sale area is allocated for the student's participation. Creativity involves breaking out of established patterns in order to look at things in a different way. We insist the importance of capturing display techniques which play a vital role in attracting the customers.

Obstacles faced / Problems encountered:

• The student's issues are mostly related to time management. This becomes a critical issue for the students involved in a competition. As deadlines approach, a tendency for many students is to let their class work slip and force too much of their effort on the competition.

- Good advising and proper planning canbe a long way to avoid this problem. But sometimes it is extremely difficult to keep the students focused on class work when the adrenalineof the competitions is so much more compelling.
- Technical issues as well relate to the availability of resources. Students have difficulties in sourcing of raw materials such as fabric, accessories, identification of models, forecasting the current trend in market, suitability to the target customers etc.,
- Lack of creative intelligence and passion is a stumbling block. The faculty advisor has to motivate the students in a positive manner towards the successful outcome of the project.
- Financial limitations may sometime limit their creativity. The advisor can seek institutional methods to support the students.
- Sometimes students lack flexibility to incorporate changes in the design cycle during the product development process which may arise conflicts between the advisor and the students which has to be dealtin an amicable manner.
- Failure at competition may cause the students to get frustrated and disappointed. It lies in the hands of the advisor to make them reassured of their confidence levels and motivate them for a successful career ahead.

Impact of the Practice / Evidence of Success:

- The practice offers the faculty to have a close involvement with students in an informal setting and thereby improves the faculty's ability to understand the student as a whole.
- To enable the students to reach forward into their curriculum for analysis and design aspects during their task of accomplishing the project.
- Competitions provide opportunities for the emerging professionals to be recognized by the industry recruiters for their fresh ideas and acts as a platform to showcase their work
- Students get a first hand sense in the importance of the following:
- 1. Following a schedule
- 2. Communication and Coordination
- 3. Designing to a budget, Market research
- 4. Knowledge about products
- 5. Creation of innovative products
- 6. Academic improvement, Managerial skills and Competency
